By signing and filling out this form I am authorizing Alamo FCU to skip a month on the payment on my loan(s). I am aware that a \$20.00 processing fee will be charged per loan request.

**NOTE:**

- Member must have loan at least 6 months before requesting a skip-a-payment.
- A request for Skip-a-Payment received 5 working days before due date will incur an additional \$10.
- A limit of 4 skip-a-payments during the life of loan.

I also acknowledge that I will not be able to request another skip a payment on my account whether or not I choose one or all of my loans to be skipped for at least 6 months.
